## IMPACT ASSESSMENT FOR SOCIAL AND ECONOMIC DEVELOPMENT

### CONFERENCE THEME AND OBJECTIVES

Social and economic development don't always go hand in hand. Social development should be understood not only as a result (income growth and poverty reduction) but also as a process of change that leads to equality, social and environmental justice, cultural recognition, and democratization of politics. For this, increase in public participation in decision-making is a fundamental component of social development.

Social and economic progress leads to a gradual social evolution that produces a better quality of life, but at what cost? Economic progress often generates environmental effects that, even though they are not immediately evident, may adversely impact biodiversity and natural resources.

In IAIA14 we expect to look at the role of the various instruments of impact assessment on the promotion of social and economic development, considering the importance of the assessment process itself as well as its results. At the Conference, experiences and ideas will be shared about how IA outcomes may include efficient and innovative ways to promote social and economic development to benefit quality of life, now and for future generations.

## SUBMISSION INFORMATION

### PROCEDURE

Conference submissions take place in three phases.

**1. Session proposals.** Through 6 September 2013, session proposals are invited. Accepted sessions are listed in the preliminary program in October.

**2. Paper and poster abstract submissions.** From September through December, papers and posters are invited on the topics and sessions listed in the preliminary program. Accepted papers and posters with the primary author registered by 7 January are listed in the final program.

**3. Papers for online proceedings.** From January through 14 February, paper and poster presenters are invited to prepare 5-page papers to be included in a paper review process for online proceedings. To be published online, the paper or poster abstract must have been accepted by the program committee, and the presenting author must be registered with fees paid by 7 January.

Detailed instructions for paper preparation and submission are provided to authors upon both submission and acceptance of a paper or poster abstract.

### LANGUAGE

English is the primary language used at IAIA conferences. Unless otherwise noted in the preliminary or final program, sessions will be held in English.

### ACCEPTANCE AND REGISTRATION

Session organizers and authors will receive an immediate confirmation of successful online submission. If you do not receive an immediate confirmation of submission, do not assume it has been submitted. Please try again or contact [webmaster@iaia.org](mailto:webmaster@iaia.org) for assistance.

The Program Committee will notify session organizers of acceptance status for sessions between 6 August and 23 September.

Session chairs will notify authors of papers or posters of acceptance status by 20 December.

All session chairs and presenting authors or speakers listed in the final program are required to submit a registration form, with full conference fees paid, by 7 January 2014. Please submit an abstract only if you will have funding to cover your travel and registration. Individuals notable to comply with the registration requirement will not be included in the program and proceedings.

**REMEMBER:** Early registration will also save you money! IAIA does not have funds available to pay registration and travel expenses for program participants.
