: PLENARY SESSIONS

The Tuesday morning plenary session will be devoted to the central theme of the meeting: how to make IA a more effective tool for planners and decision makers. Decision makers from both policy and business backgrounds will share their visions with us on this important topic. Also during the morning, IAIA's Global Environment Award will be presented to Mr. Jan Pronk, Dutch Minister of Public Housing, Spatial Planning and Environment.

The afternoon is devoted to a new type of IAIA plenary: problem-solving sessions. Participants are challenged to generate solutions to the issues and problems raised during the morning. Discussions will take place in five smaller groups. In each of these groups we have asked a keynote speaker to address issues from a regional perspective - Africa, Asia, Latin America, Europe, North America/New Zealand/ Australia - to kick off the general discussion on how to improve IA effectiveness. Participants are asked to indicate their preference for one of the sessions at the registration desk.

On Thursday morning, three plenary sessions are scheduled. By special invitation of IAIA's Board, the first session will highlight some typical Dutch approaches to impact assessment and decision making. How to Get the Most from This Conference

Make a goal sheet. Why did you decide to register for this program? What is it you expect to gain? Take a moment right now to think about your goals. Write a "Dear Boss" letter. If your boss or company sent you to the conference, thank them with a letter. Include a list of your "action ideas" based on your action plan -- what you intend to do or change as a result of what you have learned. If you paid your own way, still send the letter. It will show how committed you are to your own professional growth.

Enjoy yourself. Start relaxed and you'll leave refreshed, inspired and recharged. Forget about what's happening at the office -- unless you have unusual telepathic powers, you can't do much about it anyway. This is your conference. Get all you can out of it and have a good time.

WORKSHOP 1 SEA

Whilst during much of the 1990s confusion existed around the decision making instrument strategic environmental assessment (SEA), it is probably fair to say that more recent years have seen a rather impressive growth in its appreciation and understanding. Based on the results and conclusions of recent research studies, meetings, and conferences, it appears more clarity exists as how to properly apply SEA in different situations and contexts. This particularly includes the use of SEA in achieving sustainable development in terms of previously defined (but possibly flexible) objectives and targets. Furthermore, there is increasing appreciation of the tiered nature of SEA and the need to fine-tune the process to specific requirements of the underlying policy, plan or program. All this means that SEA has now become a mature instrument, waiting to be extensively applied. However, despite this impressive progress, SEA is currently still not as widely known as one might possibly expect from this potentially very beneficial decision making support instrument. "Selling" SEA, therefore, is currently one of the most urgent tasks the SEA community is faced with. In this context, the positive role of SEA in effective decision making needs to be better highlighted and success stories need to be told. In particular, the simple, integrative and flexible nature of SEA and its potentially positive role in helping to avoid wasting natural and financial resources should be stressed in order to convince practitioners to use SEA.

WORKSHOP 2 Social IA

The most recent workshop on these was held at IAIA'01 in Cartagena, Colombia. It is now time to be charting some other new directions, based on what practitioners and users of SIA believe to be the current issues for professional practice and professional development in various countries around the globe. The conference theme for IAIA'02— "how to make impact assessment a more effective and stimulating tool for planners and decision makers"—provides us with a good opportunity to reflect, discuss, and decide on some new professional directions and priorities.

Workshop 3

Public Participation in IA

This workshop will focus on themes closely related to the Conference's overall theme: assessing the impact of impact assessment. We solicit contributions that focus on the impact of public participation and stakeholder participation on (strategic) impact assessment and policy making. Contributions with an evaluative and/or prescriptive character, suggesting how to make strategic/environmental impact assessment suited for public participation are very much welcomed. Contributions from developing and transitional countries are especially sought.

Two more themes will be addressed: the role of electronic communications in public participation and the stakeholder involvement/public participation dichotomy. Electronic communications from Internet to group support systems are penetrating rapidly into our fields. How are they being used? How do they support public participation? How do they contribute to the quality of impact assessment? What approach is preferred at what stage in strategic planning processes and impact assessment? Whom to involve: the general public or selected stakeholders? How does this choice affect the outcomes of impact assessment? The sessions on public participation will be participative. We explicitly solicit contributions that allow for direct interaction and discussion, fun and excitement!

Workshop 4

Human Rights

There is growing consensus on the need for more systematic, in-depth and transparent reporting on the formulation and implementation of policies, in order to assess the combined effects, to learn from results and to enhance accountability. Within the human rights community, research institutions and various intergovernmental bodies' activities are taking place concerning the development of instruments to measure human rights performance. At the same time, there is an increasing call at the political level to assess the impact of policy measures. The challenge is to combine these trends for the benefit of human rights promotion and protection. Human Rights Impact Assessment (HRIA) could be of assistance in this process. The following issues will be discussed:

- Lessons to be learned from existing IA approaches such as Strategic Environmental Assessment.
- The constituent elements of HRIA for policies with an external effect.
- Developing a framework; the focus will be on foreign affairs and the broader area of external relations.
- The function and place of HRIA in decision-making processes.
- Identification of the needs of policy-makers, parliamentary bodies, academics/human rights institutions and NGOs; bringing together the demand and supply side.
- What is needed at different levels of decision making and for different policy areas.
- How can these needs be met; how to make HRIA user-friendly, costeffective, tailored to different policy areas and levels of decision making.
- How to move forward at academic, NGO and governmental level.

WORKSHOP VISIONS OP VISIONS

WORKSHOP 5

Health Impact Assessment— Opportunities for Healthy Policy Making

In the Health Impact Assessment (HIA) stream, the question is put forward: what opportunities for healthy policy making are provided by HIA and what opportunities are there for HIA researchers to be "heard"? What happens with HIA results? Do they meet information needs of policy makers, interest groups, and other stakeholders?

On every policy level—international, national, regional or local—interest in HIA is growing under those designing programs or projects, including agencies such as the EU, WHO and World Bank.

Opportunities are provided by crossboundary cooperation in impact assessment. Policy-influenced determinants of health comprise lifestyle, physical, economic, social circumstances, and health care. HIA crosses borders, sometimes linking up with EIA or SEA, with SIA or other IA.

Presentations and sessions in the HIA stream refer to the inclusion of health in prospective assessment of policies, programs and projects or through strategic assessment.

Stream themes:

HIA kaleidoscope

This 'warming up' session will be the kick-off for the HIA stream. A number of instruments, approaches, and methods will be presented, focusing on HIA as a tool for healthy policy making.

HIA in practice

In this session HIA carried out in different fields and contexts will be presented. The scope will be to define success factors for HIA. What works? When does HIA have a clear impact on policies, programs or projects? And how can we improve our work in this respect? Examples from practice will show opportunities and difficulties encountered in the HIA process.

Effective instruments for HIA

In this workshop several tools, instruments, and methods developed for

HIA will be presented, focusing on their effectiveness regarding healthy policy-making.

Qualitative and quantitative data: the evidence base for HIA

If HIA is to have any impact on policies, programmes or projects, the predictions made should be plausible, credible and usable for policy makers as well as for other stakeholders. What does this mean for the evidence base of HIA? How 'hard' should data be? Can we perform HIA on policies/programmes which are difficult to assess for quantitative health effects? Under which conditions? Should elements such as well-being or quality of life be integrated in HIA? These are some of the central questions of this session.

The way forward: should health and social impact assessments be integrated?

This session will be organised as a panel discussion. Through an open dialogue format, the session will explore the feasibility and desirability of integrating Health and Social Impact Assessments into a Human Impact Assessment, and what may be necessary to proceed if integration is considered viable.

Integrative approaches

In this session the focus will be on integrating HIA with other IA in a general sense. The aim is to identify questions -and perhaps answers- regarding theory, practice, and strategy. In the last session of the HIA stream these questions will be addressed from a very practical perspective.

HIA in its societal context

In this workshop the central topic is how HIA can relate to different stakeholders and sectors, focusing on implementation of HIA results in projects, programs, and policies. Opportunities and challenges posed by different (policy) contexts will be discussed.

Identifying the key challenges and issues in implementing and integrating HIA.

This session will review the recent practical experience in implementing and trying to integrate HIA in the IA of development and sectoral policies, including in EIA and SEA. Country perspectives and experience and current international developments will be reviewed to learn from successes, identify constraints, and propose next steps that could be taken to facilitate that further implementation of HIA can adequately answer current challenges for the health sector. The session will be set up as a dialogue workshop, and the results will be fed into the planning of the new WHO HIA programme.

 EIA?
- The Convention on Biological Diversity (CBD) Guidelines on Biodiversity in EIA: How successful has implementation been at country level. The guidelines on Biodiversity in EIA endorsed by the SBSTTA 7 (Nov 2001) have a generic format. Are there any pilot projects attempting to implement these guidelines and incorporate them into EIA?. How appropriate and practical are the guidelines in implementation? Can we further refine the implementation steps required? (SBSTTA = Subsidiary Body on Scientific, Technical and Technological Advice of the Convention on Biological Diversity)
- Traditional Knowledge: How do we ensure we incorporate traditional biodiversity and ecological knowledge and perspectives into EIA, SEA, and baseline information acquisition? Can traditional knowledge help overcome the huge gaps in baseline information needed to incorporate biodiversity in IA?

 Industry and Business: Perspectives from the end-users; how do we ensure practical incorporation of biodiversity and ecology into IA and not create another theoretical stick to beat industry/developers with; can we devise a "team approach" with regulators which effectively incorporates biodiversity and ecology?

Time is set aside in this workshop to try to pull these different areas together, depending on the response to each of the above topics.

WORKSHOP 7 Sustainability IA

Sustainability is the focus of convergence for several overlapping approaches to impact assessment. These are variously labelled and defined. Some of the terms used include environmental assessment for sustainability assurance (ESA), integrated environmental management, integrated impact assessment, and sustainable development assessment. A broad, flexible interpretation of this emerging sub-field is encouraged for this workshop, which addresses the following aspects and areas relating to the theory and practice of impact assessment as a sustainability instrument:

- Operational definitions, principles and criteria of sustainability processes and procedures for incorporating and applying sustainability as part of assessment.
- Methods and tools for assessing the sustainability of development proposals and activities.
- Case studies and examples of use of impact assessment for this purpose.
- Practitioner competencies, skills and types of expertise that are required to conduct sustainability assessments.

WORKSHOP 8

Integrated Impact Assessment

There is a risk that when we talk about "integration" it invariably means different things to different people. A 'road map' for change was first devised at IAIA'99 in Glasgow and developed further at IAIA'00 in Hong Kong. This will be used as a baseline for The Hague workshop, enabling discussion of progress and trends. Although significant progress has been made over this 3 year period, there perhaps remains a large gap between potential and practice in striving towards the goal of more sustainable development.

A diverse range of papers, involving several aspects of integration, has been received in response to the original vision put out in the preliminary programme. Some are concerned with tools and techniques for combining environmental, social and economic aspects, many with the integration of social issues into EIA, and others with more efficient ways of informing decision procedures. The papers have been grouped into 3 sessions: the first concerned principally with what is meant by integration and integrated approaches; the second on integrating social processes and impacts into EIA, and the third covering some perspectives on future directions for integration.

WORKSHOP 9 Cumulative IA

The Cumulative Effects Workshop will present information directly relevant to the IAIA'02 theme. Assessing the cumulative effects (CEA) that exist is a study of all impacts in an area, the impacts of a project being reviewed in combination with those of other human activities, i.e., the real summation of effects as opposed to those that are based on a specific project. To make effective decisions on any project, the decision maker (be it regulator, proponent, affected public, or financial lender) must give consideration to how a project will "fit" (ecologically, socially, etc.) into the existing situation. Thus, one must know the state

of the receiving environment, i.e., the cumulative effects. Without such a context, project decisions are too often ineffective.

Although the practice of cumulative effects assessment has been maturing as processes and models are developed, many fascinating avenues are yet to be explored. This IAIA'02 workshop will present the latest progress on methods for:

- Managing cumulative effects –challenging the traditional roles of our agencies and jurisdictions.
- Integrating project CEA with regional land use and social thresholds.
- Applying CEA principles particularly in developing countries where EA has gained a foothold.
- Accepting the importance of CEA we cannot ignore the real, total effects on the land and/or our social structures.

WORKSHOP 10

IA Follow-up

This workshop is intended to fulfill a number of objectives:

- 1. Share good experiences in (E)IA follow-up, especially in relation to decision-making and issue management in post-EIA stages.
- 2. Promote the network of practitioners involved in follow-up.
- 3. Discuss and develop an international framework that may be used for conducting follow-up.

The workshop will bring together practitioners of (E)IA to share their experiences and knowledge regarding EIA follow-up, focusing on experiences in EIA follow-up pertinent to decision-making and issue management. Good examples and cases demonstrating the usefulness of EIA follow-up for decision making and management, and ways to enhance the relevance of EIA follow-up in this regard, are sought. In this regard, the workshop builds on earlier EIA follow-up workshops in the last two IAIA conferences.

The workshop format will include presentation sessions of some ten papers (preferably based on recent case studies or research) and a plenary session led by the workshop organizers. A draft of a framework on follow-up will be presented and discussed at the plenary session in an effort to develop it further and to make it applicable at an international level. As in earlier years, the workshop will produce a CD-ROM containing the proceedings of the workshop and a collaborative article from the results of the workshop could be authored for publication in a journal (e.g., Impact Assessment and Project Appraisal).

WORKSHOP 11 EMS and Auditing

Environmental Management Systems (EMS) provide a framework within which environmental policies and objectives can be set and monitored, and roles and responsibilities are assigned and checked. One well-known EMS standard is ISO 14001, an internationally recognized standard that sets forth the requirements of an EMS: Environmental Policy, Planning, Implementation and Operation, Checking and Corrective Action, and Management Review.

Identifying aspects, impacts, and mitigation measures is common to both an EMS and EIA. The EMS helps manage the environmental impacts and initiatives, and helps ensure the organization is on track to meeting its environmental commitments. EMS can be structured to include and build on the evaluation, assessment, monitoring, reporting, reviewing, and other management activities associated with environmental assessment. It follows the simple "Plan Do Check Act philosophy"—plan what you're going to do, do what you plan, check what you've done, and act to review and improve.

EMS is a practical way to manage the organization's impact on the environment and to ensure everyone in the organization is involved. It also helps organize records and reporting, so in the long run, it saves time and money. Progress can be monitored and evalu-

ated against the objectives and goals that have been set. These features of an EMS can help decision makers determine priority areas within their organization where they'd like to see progress made and where resources should be allocated.

WORKSHOP 12 IA in Industry Development

Industry leaders have recognized that a properly timed and well-organized IA contributes to improved design, minimization of long term risk and communication with a wide range of stakeholders. However, IA is still seen by some as simply a hurdle to be overcome in the regulatory approval process. In such cases, the focus remains on limited environmental impacts, and inadequate and poorly designed assessment processes end up providing little long term value. Objectives of this session:

- Document best practice in industry EIA, including developed and developing countries.
- Demonstrate how and where project changes have resulted in more appropriate design and execution.
- Indicate how the use of social and health impact assessment is adding value to the development objectives.
- Demonstrate the integration of the EIA process within project planning to address key social, structural or environmental issues.

Participants will be those who are actively engaged in industry IA as proponents, consultants, civil society or governmental regulators. Points of view will be welcomed from all sides. It is expected that excellence in performance, new techniques, means to engage stakeholders, and integration of all aspects including social, environmental, biodiversity and health will be presented and discussed. New means of applying IA concepts will be explored and ideas to make EIA more efficient through the use of management plans, monitoring programs, community and independent inspections will be welcome.

WORKSHOP 13

IA of Urban Development

The world of the 21st century will be an urban world. Current assumptions expect that by 2005 more than 50%, and by 2025 approximately 2/3 of the world population, will be living in urban areas—amounting to some 5 billion urban residents. Ninety percent of this growth will occur in countries of the developing world. In parallel, cities are becoming the world's key social, economic, cultural and political framework—the test-bed for the adequacy of political institutions, the performance of government agencies, and the effectiveness of programs to combat social exclusion and economic development projects (CERFE/ UNCHS, 1995: Review of Current Trends in Economic and Social Development; Research Project, Draft Final, Sept. 1995). Given the strong relation between (national) economic growth and urbanization, it is now accepted that urbanization is not only inevitable, but is also a positive phenomenon without which the economic development gaps between the richer and the poorer countries can never be mitigated. Globalization, sustainable development, and the changing role of nation-states and government are the setting for future urbanization processes. For better or for worse, the development of contemporary society will depend largely on understanding, managing and guiding the growth of

This workshop will look at ways and means of cities and urban areas in addressing the challenges of blending economic growth with social and environmental sustainability. Which tools and instruments of planning and impact assessment are applied to address these issues – and how are they combined? How do the different levels of decision-making – from national to local – interact? These are but a few questions the workshop hopes to address. Planners and environmentalists alike are invited to participate.

WORKSHOP 14

Environmental Legislation

This workshop intends to assess how environmental legislation on impact assessment is implemented, and how decision makers in companies and institutions realize the maximum benefit impact assessment as an instrument can have for achieving more sustainable projects, programs, plans and policies in all sectors of the economy.

Specifically, the workshop intends to open and develop a debate on difficulties, problems and successes of environmental legislation as to:

- Full implementation of Strategic Environmental Assessment of programmes, plans and policies (including trade policies).
- A more demanding monitoring of EIA-SEA.
- Real public information and participation in decision making in impact assessment in light of the Aarhus Convention.
- A more accurate integration of impact assessment within institutional matters, including institutional economics.

The workshop will analyze the links between legal and institutional organizational matters in the decision making process and the implementation of impact assessment.

WORKSHOP 15

Impact Assessment of Dams and Water Projects: Beyond the WCD Report

The World Commission on Dams report highlights EAs and SAs as a key tool for decision making on dams. This could be an opportunity to review the practice of EAs of dams and water projects, and how they evolved to meet new demands from various social actors and decision makers. Topics to be discussed include: What changes could be expected in the study of future dams in light of the WCD conclusions and recommendations? How can the "development effectiveness" approach to EAs of dams and water projects be integrated? Can EA/SA respond to the broadened agenda around water projects? How

do the technical and political processes interact in the preparation of EAs and SAs?

Workshop 16

IA & Transboundary Water Issues

Decision support based on studies of environmental impacts and cost benefit analysis is a special challenge in a transboundary context. Increased need to international agreements on water management, infrastructure and economic development calls for joint planned and vision development in cross-border regions. International treaties such as RAMSAR and the Habitat Directive of the European Union focus on the quality of natural habitats of, e.g., rivers and estuaries itself, while the decision makers will have to deal with national interests and political borders. International treaties bring the obligation to compensate for environmental damage; compensating measures must be an integrated part of the projects involved. How can we maximize benefits from joined vision and policy planning when economic benefits of the project will be mainly for one country and environmental damage for the other? How to deal with cultural differences and different regulations when joined planning and vision development is needed? How to overcome traditional differences in interpretation of facts and figures? And what do the decision makers want to know from EIA and cost benefit analysis in transboundary projects?

The two sessions of the workshop will deal with

- 1. Methodology of joined vision development and policy planning.
- EIA and cost benefit analysis in the transboundary decision making process.

During the workshop, the case of the Schelde Estuary will be highlighted. As part of the conference, a technical visit to this site is organized. The Schelde Estuary case is a joint project between the Netherlands and the Flemish Region in Belgium. It proves that decision-making in an international context can be made more coherent when it is based on a long-term vision that is shared by the countries involved. The methodology of this

case will be compared with other experiences in transboundary situations.

WORKSHOP 17 IA In Region Eastern Europe

This workshop focuses on EIA/SEA capacity building within a post-war reconstruction of the Stability Pact Countries (countries of Southeast Europe). Discussion items will include:

- Introduction to capacity building framework.
- Comments by participating countries which do not yet have EIA regulations (Albania, Macedonia, Yugoslavia, Bosnia, and Herzegovina).
- Discussions on the effectiveness of this approach (comments from donor agencies and other participants at the session).

WORKSHOP 18

Impact Assessment in Asia

Asian regions have their own EIA systems and informal rules based on deep-rooted traditional cultures and religions. Asian countries have been using EIA system to improve their decision-making as it applies to environmental conservation and sustainable development. It is expected that EIA will be implemented effectively, not only at the project level, but also, at the policy level. Our Asian regions create a vast potential for extensive regional cooperation within the EIA. This workshop will discuss the following topics:

- future options for SEA in China
- impact on water quality in Korea
- environmental cooperation in northeast Asia
- development of an integrated water treatment system in Korea
- remediation of the contaminated harbour sediment in Hong Kong
- consideration of alternatives regarding environmental impact assessment

WORKSHOP 19

Impact Assessment in Africa

Since the Durban AMCEN (African Ministers Conference on Environment) Meeting in 1995, EIA has received increased attention in Africa. Various African countries are currently at different stages of development of their EIA systems. There are also a number of on-going initiatives to ensure that EIA is implemented more comprehensively on the continent, with appropriate linkages and synergies.

In order to expedite a more effective adoption of EIA systems in Africa and link up various initiatives, this workshop has been planned to bring together various actors (i.e., development partners, African country representatives, relevant national, sub-regional, regional, international organisations and other interested persons) to

- discuss ways of harmonising EIA capacity development efforts on the African Continent;
- ii) improve provision of information to African countries, sub-regional, regional, international organisations and donors; and
- iii)provide a platform for the discussion of ongoing EIA activities in Africa

WORKSHOP 20

Workshop Vision: Impact Assessment for Linear Infrastructure Projects

Linear infrastructure projects like roads, railways, waterways and energy lines, share unique features that require high quality standards in impact assessment. Areas are irreversibly altered: landscapes are dissected, habitats are destroyed, humans and animals are affected by traffic, noise, air pollution etcetera. In addition, the realisation of infrastructure may have impact on the social and economic structure and development. This can be viewed both positive and negative. Therefore, impact assessments for linear infrastructure should deal with prevention,

mitigation and/or compensation of the negative impacts and promote positive impacts. Decision-making on infrastructure is characterized by the NIMBY-nature of the projects (NIMBY = Not in my backyard). In addition, the growing concern on infrastructure is reflected in, for instance, the troublesome implementation of several EU-directives, like the Birds Directive. Habitats Directive and the Directive on Local Air Quality. An European Directive on Noise is being prepared now. In short, impact assessment and decision-making on infrastructure projects are complex. The major objectives of this workshop is to discuss such issues as:

How can impact assessment contribute to sound decision-making and sustainable projects in this field?

How to deal with prevention, mitigation or compensation of negative impacts? How can we improve the quality of IA in such a way that pristine areas can truly be protected from being dissected, disturbed or even destroyed by infrastructure? How to balance short-term versus long-term, human versus nature, project and cumulative impacts? Share good experiences in impact assessment for infrastructure projects?

WORKSHOP 21

IA and Information Technology

Vision: Information and communication technology (ICT) and knowledge management have an increasingly important potential as instruments of sharing knowledge among stakeholders in a planning process. Knowledge systems promise to make information available for improved problem analysis and understanding, facilitate learning from experience, and facilitate exchange of knowledge and experience worldwide.

Mission: The aim of this session is to inventory the state of the art with respect to development of ideas and actual use of ICT in impact assessment and to provide guidelines for starting up a new IAIA Section under the working title "Information, Communication and Knowledge Manage-

ment." Contributors to the session are persons who find a basis for their work in ICT and software-supported instruments and methodologies for integrated assessment planning and decision making. They are not only the actual software developers, but also people who understand and apply the principles of ICT in their work as EIA practitioners and integrated planners.

The session will focus on the potential of ICT to facilitate the EIA process in as many ways as possible. This may be about concepts as well as practical examples of how IT is used in specific software packages. Background information can be found at www.DR-EIA.org, where an example of a knowledge system for impact assessment can be found as well.

WORKSHOP 22

IA Training & Capacity Building

IA's impact, and its success in promoting informed decision making, depends in large part on the expertise of IA practitioners and the capacity of IA organizations. The session format will consist of traditional paper presentations and potentially a workshop or round table to discuss issues such as the UNEP manual, IA certification, and means for developing in-country training.

WORKSHOP 24 IA of IAIA'02

On request of the IAIA Board of Directors, an impact assessment for IAIA'02 has been prepared. The Impact Assessment Report has been drafted by an international group of students of the technical University Delft. For their work, the students have built on the first experiences gained with a (post-) impact assessment for IAIA'02 in Cartagena.

During concurrent workshop session(s) the IAIA'02 organization wants to discuss two main issues with the participants of the conference in The Hague:

- What can we learn from this year's experiences for preparing impact assessments for future IAIA conferences? This relates to both process and substantial aspects and will be discussed with (among others) members of the various IAIA Sections.
- 2. What can we conclude on basis of the results of the impact assessment for IAIA'02 and effectively meeting the conference objectives? This relates to the way IAIA conferences are organized and will be discussed with (among others) members of the IAIA Board. In this regard, the issue of monitoring and follow-up is also relevant.

WORKSHOP 25

Linking IA & Management Tools

As the concepts associated with sustainable development mature, and new and modified decision aiding tools are developed, so links between environmental assessment and management tools become all the more essential. Increasingly there is experience of trying to make links between tools, e.g., EIA/SEA and EMS, LCA and SEA, SEA and Sustainability Appraisal, etc. The purpose of this workshop is to exchange experiences and to discuss theoretical and practical linkages between tools that can be made and further developed. The workshop will offer the opportunity for real brainstorming and discussion among colleagues from a wide range of disciplines. The aim will be to produce a report from the discussions and recommendations for further action. including to perhaps establish a network/Section concerned with links between tools. If appropriate, the report could be considered for publication in the *Journal of Environmental* Assessment Policy and Management.

WORKSHOP 26 IA in World Trade

UNEP is seeking an extensive and wide range of networks and expertise in recent approaches and techniques in the field of environmental and integrated assessment which can constructively contribute to the work of UNEP/ETB in integrated assessment of trade-related agricultural policies. Specific topics to be discussed at the session include:

- The impact of Common Agriculture Policy on agriculture and the environment in the European Union.
- The impact of US agricultural policies on agriculture and environment in the US.
- The impact of agricultural policies in developing countries on agriculture and the environment in those countries.

- The impacts of export-oriented crop production on the environment in major agricultural exporters (e.g., the Cairns Group of countries).
- The transboundary impact of subsidies provided in one country, on the agricultural sector and the environment in other countries.
- The environmental effects of agricultural commodity prices, and changes in those prices.
- The impact of trade liberalization on agricultural biodiversity, which is the subject of a mandated assessment by the Convention on Biological Diversity.
- The observed and potential environmental effects of GMOs released into the environment by commercial agricultural use.

Participants are invited to indicate their specific areas of interest and expertise in any of the above areas and their submission of written contributions and research work on any of the above topics, as well as to highlight assessment techniques and/or research findings that can assist in assigning causality of environmental effects to specific policy measures of changes.

WORKSHOP 26

Part 2: Integrated Assessments and World Trade Policy, Post-Doha

The main aim of this workshop is to explore how new forms of impact assessment may be developed and used in world trade negotiations to promote sustainable development.

The recent World Trade Organization Ministerial Conference, held in Doha (Qatar), launched a major new programme of World Trade negotiations which could have profound economic, environmental and social consequences. At the same time, it strongly re-affirmed its commitment to the objective of sustainable development. This provides a timely incentive to develop new methodologies and use these in trade impact assessment studies to support this objective.

The workshop will commence with the presentation of two papers, partly based on recent and ongoing European Union-supported studies at the University of Manchester, UK, on the Development of a Methodology for the Sustainability Impact Assessment of WTO Negotiations. Three additional papers expand further on these themes.

Time has been designated in both Thursday and Friday Part 2 Sessions to consider the IAIA'02 Theme and to provide some degree of input back to the Conference organizers.

WORKSHOP 27 **Quality in Impact Assessment**

Quality in Impact Assessment (IA) has increasingly come under the spotlight in recent years, along with growing experience of its application. The quality discussion encompasses a wide range of fields, such as the implementation of different steps of the IA process, the contents of Impact Statements, techniques and methods for assessing impacts, procedures for public participation as well as an increasing focus on the outcomes of the process.

The discussion on quality in IA is furthermore central to the main theme of this annual conference, closely connected to the discussion on the overall aims of IA and its impacts on decisionmaking.

Significant questions in this discussion include:

- What constitutes quality in IA?
- · How is quality ensured in the IA process?
- What are the expectations of different stakeholders to the process, e.g. the public and the decision makers?
- · Does good quality IA lead to better decisions?

The aim of the workshop is to present how quality is addressed in IA, give examples of measures to enhance and review quality as well as to discuss the relevance of quality for the impacts of the IA process.

The workshop format will include presentations of papers, followed by a panel discussion led by Bobbi Schijf.

- knowledge of impacts and other consequences is one, wanting a certain decision something else.

The workshop will offer a lot of opportunity for participants to ask, discuss and learn from Dutch practise. Therewith Dutch practitioners hope to learn from critical questions and discussions with international colleagues. The workshop will have two successive sessions with differing cases and discussion angles.

Knowledge Utilisation in Policy-Making

In 2000, RMNO (Dutch Advisory Council for Research on Spatial Planning, Nature and the Environment) made a survey of cases of knowledge utilisation in policy-making abroad that are considered to be examples of good practice. This survey included the European Commission, the European Environmental Agency and Germany, France, the United Kingdom and Sweden. The survey was intended to give an overall picture, not a

detailed analysis of the utilisation of knowledge in these cases.

From this survey, several conclusions were drawn for further work:

- It is difficult to make a clear distinction between successful policies and the successful utilisation of knowledge in policy making;
- It is not interesting to analyse success stories in environmental policy, but a detailed analysis of the interaction between science and policy making is interesting in cases of integrated policy-making around which controversies in society exist;
- A comparative study should explore the different designs for interfaces between policy and science rather than analyse different policy cases as such;
- Not only the interaction between science and policy should be studied in these models, but also the interaction with society. The reason for this being that sometimes knowledge gets in by citizens or societal groups, thus influencing the political agenda.

The overall conclusion of this survey is that it makes sense to compare different designs (models) for the interaction between science, policy and society that have evolved in several countries and in international organisations.

The aim of the workshop is to hear from participants from several countries about characteristics of these interfaces. What is considered to be good practice? I.e. what are the characteristics of the interface between science, policy and society in particular countries, especially regarding complex environmental problems.

We may consider some interaction "models" in more detail and see to what degree their characteristics are influenced by the local culture and what characteristics are possibly common for several European countries.

WORKSHOP 32

European Forum on Integrated Environmental Assessment (EFIEA)

First, the European Forum on Integrated Environmental Assessment (EFIEA), which consists of almost 40 partner institutes, will be briefly presented (goals, structure and planned activities) by Mrs. Minnesma. Thereafter, two or three leading members of the EFIEA network will discuss the similarities and differences between Integrated Assessment (IA-1), Impact Assessment (IA-2), and Strategic Environmental Assssment (SEA). These three fields of interest move more and more in the same direction, which increasingly creates overlap in the three domains. SEA used to be mainly directed towards environmental impact assessments, but moves more and more towards more flexible, interactive and participative impact assessments. The domain of impact assessment on the other hand moves into the direction of more integral analyses, including analyses about driving forces and causal factors. The speakers welcome a lively debate on this topic (approximately 30minutes), hoping to bridge the gaps between scientists in different domains.
