Activities of Advisory Committee


- Advice to review of JICA for projects categorized in A (and B if necessary)

Distribution of 24 members' attributes










Numbers of Meetings

Living and Livelihoods

- The Advisory Committee advised on living and livelihoods, for instance
 - Mitigating the impact of construction of roads, railways, etc. that may divide a local community or change the use of resources
 - Designing a project that shows consideration for the poor and other socially vulnerable groups
 - Incorporating in the project measures to ensure employment or restoration of livelihoods for the resettled residents.

Resettlement

- The Committee's advices include the followings:
 - Ensure that farmers, especially those not owing lands, and other vulnerable groups are also covered by compensation
 - Give sufficient explanation of the resettlement process to residents, farmers, business owners, etc.
 - Clearly define the organization and operation of a grievance redress mechanism.

Other aspects

- Explanations to Local Stakeholders
 - Involve diverse stakeholders in the planning process through wide publicity
 - Reflect the residents' views and interests on the project design
- Monitoring
 - Formulate a plan to monitor the project at operational stage and make recommendations to the executing agency
 - Place the emphasis of monitoring on the concerns of residents (noise, etc.)






Grouping of words with cluster analysis




Correspondence analysis



Distribution of projects by Sectors






Cooccurrence network

Comments of the committee on social aspects (1)


- Monitoring of the impacts to Social Institutions and Indigenous or ethnic minority during operational stage
- Importance of livelihoods' rehabilitation other than monetary compensation
- Mitigation measures on the accessibility to schools, markets, workplaces, drinking water places in the areas where relatively many people mentioned the impacts through the socioeconomic survey


Comments of the committee on social aspects (2)

- Description of the candidate on relocated areas
- Specific information on alternative lands for farmlands which are located in ROW.
- More specific descriptions on livelihoods rehabilitation as well as specific consideration on vocational training
- Monetary validation on the assistances of education, healthcare, vocational training, livelihoods rehabilitation
- Verification and necessary mitigation for the impacts to temples and schools which were mentioned at the stakeholder meetings

Project site






Outline of the project

- Construction of new railways for commuters
- Approx. 38 km from Tutuban to Malolos
- For mitigation of heavy traffic jam and related environmental impacts
- Over 1,000 affected households including illegal settlers

Advisory comments on social aspects (1)

- Description on Implementation body and methods of monitoring for Resettlement Action Plan (RAP)
- Specific selection policy on relocation areas for vendors in an affected city
- Additional members from local representatives into the organization for grievance resolution mechanism

Advisory comments on social aspects (2)

- Consideration of the gap between the people's requested sites and prepared candidate sites
 (3 of 5 are a few km from the original site)
- Description on the situation of mass-transit in 5 relocation sites, and consideration of transportation measures to schools or offices
- Description of the situation of markets, schools and clinics which local people have much concerns according to needs survey

Effects

- Improvement of project reports in view of technical aspect
- Upgrading the reports on justification and verification of the project
- Proposal of additional studies
- Advice on careful consideration to largescale projects with uncertain impacts

Challenges

- Insufficient Information at earlier stage of proposed projects
- Mixture of certain and uncertain aspects of findings
- Limited information of projects' sites
- Conflicts of views for controversial projects
- Verification of cost-performance in broader meanings (Review of past activities of the committee)
